2. The Tenth Pay Revision Commission, inter alia, recommended thefollowing on DearnessAllowance:

The DearnessAllowance be regulated at 0.524% for the State Employees for every one percent of Dearness Allowance sanctioned to the Employees of Government of India with effect from 01.01.2014.

Accordingly, it ishereby orderedthattheDearnessAllowancetotheStateGovernment employeesshallbe foreveryonepercentofDearness sanctionedtothe regulated@0.524% Allowance employeesof Government of India with effectfrom01.01.2014. The Dearness Allowance PayScales,2010intheG.Os.,2<sup>nd</sup> sanctioned inthe Revised and 4<sup>th</sup>readaboveshallberegulatedintheRevisedPayScales,2015asunder:
